- There is a \$20.00 land use fee for all riders and minders (for the entire weekend or \$10 per day)
 - Tech inspection and sign up available Friday from 3:00-5:00 PM Saturday 8:00 AM - 8:30 AM. (All riders and minders)
 - First Rider out Saturday 9:00 AM
 - Terrain - the trial will take place in the sierra foothills, which is forest, creeks and rivers.
 - Elevation is approximately 2,700-3,000 feet.
 - Practice will be allowed in designated areas only.
 - Awards will be presented each day.
 - Spark arrestors are required and will be verified at tech inspection, all bikes must have spark arrestors for practice as well or will be disqualified!
 - Spark arrestors -stamped USFS approved or type with proper screen size. Custom SA must be approved at tech for installation & screen size of .023 or less.
 - Youth Trial Friday, at 1 PM & Saturday, 10 AM Entry: Free (AMA Card required except strider class) AMA approved helmet and AMA card will be required.
 - Camping is available Wednesday to Sunday. Max \$30, \$10 per night, per camping vessel.
 - Camping is primitive, no power, no hookups, however RV's are welcome but will require leveling. For a full list of full service RV campgrounds. Visit our website.
 - Team parking available Wednesday. Space is limited!
 - No spectator riding
 - Food will be available during the day Saturday and Sunday.
 - 5 m.p.h. pit speed limit (yellow card, minimum 5 points)
 - A spectator fee of \$10 per day, \$15 for Weekend (all non participants), There will be wrist band security checks on the course. Gates Open 8:30 am each day.
 - Kids under 10 free (Parents to sign release)
 - Campfires in designated areas only. (Fire danger permitting)
 - NO SMOKING! in riding areas.
