NextGen Mototrials Youth Trial on Friday and Saturday for ages 18 months through 13yrs. Classes are: Strider, cadet, rookie, novice, sportsman. AMA membership required except for strider class. Signup opens at 8:30 AM CDT both days. Riders meeting on Friday starts at 12:45 PM CDT and at 10:15 AM on Saturday. Youth Trial starts at 1 PM CDT on Friday and 10:30 AM CDT on Saturday.

Helmets are required and riding boots, or sturdy footwear are strongly recommended. No flip flops or crocks (or similar) are permitted. Long pants and long sleeve shirts afford better protection in the event of a spill.
